Your notebook will be returned after grading is complete.

Parameters

- Include a title page stating course number and title, your name, address, phone, email, and the term (Spring 2016).
- Table of Contents
- Page numbers
- All information must be typed and neatly formatted in a manner befitting graduate credit. Handwritten work will not be accepted.
- Full sentences, and correct grammar and spelling are required.
- All handouts and supporting materials must be included.
- Please make sure all materials are securely placed in the binder before mailing.

Registration/Notebook Due Date: Please submit registrations and notebooks to Patrick Benson, postmarked no later than February 29, 2016.

Dates and Location: The 2016 Illinois Music Education Conference will take place January 27 -30, 2016 at the Peoria Civic Center in Peoria, IL.

Grade Sheets: Each registered participant will be sent a grade sheet to her/his home address upon successful completion of the course.

Transcripts: You must submit your request by completing the transcript request form or you may also fax your request with your signature and a credit card number.
